

This table lists all of the credit card cases we defended and resolved in 2008. It includes both suits on debts brought in court and claims made through the arbitration process. The table does not include cases where we were hired after judgment, nor does it include cases where we were hired solely to settle the case.

Almost all of the dismissals listed in the table are non-suits. This means the creditor has voluntarily dismissed its case, but reserves the right to re-file. Only 2 of our clients whose cases have been non-suited have had a creditor re-file.
